## Data protection, terms and conditions, penalty charge and image authorization

By registering for the conference, I automatically accept all terms and conditions and agree to the following penalty charge, Image authorization and data protection information.

In the context of the initiation, conclusion, processing and repackaging of BayernMUN 2018 on the basis of these General Terms and Conditions, the Provider shall collect, store and process data and pictures. This is done within the framework of the legal provisions. The UNSN, as an organizer, does not pass on any personal data of the participants to third parties, unless he is required by law or the participant has expressly consented beforehand. If a third party is used for services in connection with the editing of processes, the provisions of the German Federal Data Protection Law are complied with. The data communicated by the participant in the course of the registration process is handled exclusively for the purpose of making contact within the framework of the conference development and only for the purpose for which the participant made the data available. Once payment is available data are passed on to the credit institution which is responsible for the payment. As long as UNSN takes storage periods of a commercial or fiscal nature, the storage of some data may take up to one years. During the registration on the BayernMUN website of the provider, anonymized data, which do not allow and do not intend to conclude any inferences regarding personal data, are recorded, in particular the IP address, date and time. At the request of the customer, the personal data will be deleted, corrected or blocked within the scope of the statutory provisions. A free of charge information about all personal data of the customer is possible.
