## Data protection information regarding the production and use of photographs and/or video recordings in accordance with Art. 13 GDPR

**1. Name and contact details of the controller:**

**2. Purpose of the processing:**

The photos and/or videos exclusively serve the public relations work of UNSN and its projects FAUMUN and BayernMUN.

**3. Legal basis of the processing:**

The processing of photos and/or videos (collection, storage and transfer to third parties (see 4,5 below)) is based on the express consent of the data subject or their legal guardian in accordance with Art. 6 section 1 letter a GDPR. The publication of selected image / video files in (print) publications of the organizer and on their homepage / Facebook or similar accounts is necessary for the public relations work of the organizer and thus serves to protect the legitimate interests of the parties involved in accordance with Art. 6 section 1 letter f GDPR.

**4. Recipients of personal data:**

The photos and/or videos will not be passed on to third parties. 5. duration of storage of the personal data: Photos and/or videos, which are made for the purpose of public relations work of UNSN, BayernMUN and FAUMUN, will be stored for an indefinite period of time, subject to a revocation of the consent of the data subjects.

**5. Right to withdraw from the consent:**

The consent to process the photos and/or videos can be withdrawn at any time for the future. The withdrawal of consent will not affect the lawfulness of processing based on consent before its withdrawal.

**6. Rights of data subjects:**

Pursuant to the Data Protection Act you are entitled to the following rights:

- a) If your personal data is processed, you have the right to receive information about the data stored about you (Art. 15 GDPR)
- b) Should incorrect personal data be processed, you have the right to rectification (Art. 16 GDPR)
- c) If the legal requirements are met, you can request the deletion or restriction of the processing and file an objection to the processing (Art. 17, 18, 21 GDPR)
- d) If you have consented to the data processing or if a contract for data processing exists and the data processing is carried out by automated means, you may have the right to data portability. (Art. 20 GDPR)

Should you make use of these rights, the controller will check whether the legal requirements for this are met. Furthermore, there is a right of complaint to the data protection officer of Bavaria (Prof. Dr. Thomas Petri, [poststelle@datenschutz-bayern.de](mailto:poststelle@datenschutz-bayern.de)).

1. your consent is voluntary. You will not suffer any disadvantages from the refusal of your consent. The declaration of consent is valid from the date of signature. However, you have the possibility to revoke your consent at any time with effect for the future.

If your consent is not revoked, it is valid for an unlimited period of time.

2. please address any revocation to our contact details given above; a verbal declaration or a declaration in text form (e.g. by e-mail) is sufficient.

In the event of revocation, your personal data processed in this context will be deleted after the statutory retention and limitation periods have expired.

In the event of revocation, we are not obliged to remove already published recordings from the website or social media channels. After your revocation, however, we are prohibited from any further publication. As far as we agree to the deletion of already published recordings, this refers only to publications initiated by us. A complete deletion from the Internet cannot be guaranteed.

3. the recordings are available worldwide when published on the Internet. A further use of these photos by third parties (especially by sharing in the social media) can not be excluded.

4. if both parents are legal guardians, the consent of both parents is required. However, the signature of one parent is sufficient if the other parent also confirms the consent of the other parent. In the case of revocation, the declaration by a parent or guardian is sufficient, even if both parents had originally given their consent.

5. you have the right to be informed about the personal data concerning you and to have them corrected, deleted, restricted processing and data transferability.
